



CUPAC SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR CONTRIBUTION IS REQUIRED TO PARTICIPATE IN THE SWEEPSTAKES.

OFFER VOID WHERE PROHIBITED. SUBMITTING A SWEEPSTAKES ENTRY BY ANY OF THE MEANS IDENTIFIED BELOW CONSTITUTES ACCEPTANCE OF THESE RULES.

CUPAC ("Sponsor") is the New York state political action committee of the New York Credit Union Association. Individual contributions to CUPAC are used to support candidates who are running for New York State office.

Contributions to CUPAC are not tax deductible. Contributions are strictly voluntary and will be used for political purposes. You have the right to refuse to contribute without any reprisal. Making a contribution to CUPAC does not increase your chances of winning.

Eligibility: This sweepstakes is open to individuals residing in the continental United States, Alaska, and Hawaii. You must be 18 years of age or older as of the date of entry in order to enter. Offer void where prohibited. Employees of the New York Credit Union Association and their immediate family members are not eligible to participate.

Sponsor: CUPAC, located at 1021 Watervliet-Shaker Rd., Albany NY 12205 is the "Sponsor" of this sweepstakes.

Duration of Sweepstakes: The sweepstakes begins at 3:30 P.M. EST on 03/21/2022 and ends at 8 P.M. EST on 06/18/2022. Mailed entries must be received by 06/18/2022. Entries must be submitted to the address specified in the section below.

Two Methods of Entry: No purchase or contribution is required to participate in the sweepstakes. (1) Individuals who make a contribution to CUPAC between 03/21/2022 and 06/18/2022 will receive one entry per every \$25 contributed through the special CUPAC Sweepstakes website: <https://connect.nycua.org/cupac-sweepstakes> (2) To be entered in the sweepstakes without a purchase or contribution, legibly handprint your name, street address, city, state, zip code, telephone number, and complete e-mail address on a standard 4" x 6" postcard (with no outer envelope) and mail to: P.O. Box 15118 Albany, NY 12212-5118. Entries must be received by 06/18/2022. Sponsor shall not be liable for postal service delays. Each individually addressed postcard submitted by an individual shall be a separate entry. Sponsor shall have no obligation to notify a potential entrant of an incomplete entry. All sweepstakes entries become the property of Sponsor. Entries will not be returned. Sponsor is not responsible for entries that are lost, late, corrupted, illegible, incomplete, misdirected, or not otherwise correctly received due to technical, administrative, or human error, including, but not limited to, any software, hardware, computer or networking issues, or any other circumstances – technical or otherwise – beyond Sponsor's control. At its sole discretion, Sponsor reserves the right to modify, suspend, or cancel this sweepstakes if it appears that the integrity, security, or administration of this process may be called into question.

Prizes: Prizes are shown in the "Sweepstakes" section of the special CUPAC [Sweepstakes website](#). The **odds of winning depend on the number of qualified entries received**. The prizes shown in any materials promoting the sweepstakes are for illustration purposes only, and the actual prizes awarded to the sweepstakes winner may differ from those shown.

Selection of Winners: The random drawing for the grand prize and lesser prizes will occur on 06/20/2022 held in private at a CUPAC actual or virtual office space. The grand prize winner and additional prize winners will be notified on 06/20/2022 via email. In the event that ownership of an e-mail account is disputed, the prize will be awarded to the individual who is designated as the authorized account holder by the Internet Service Provider or other entity responsible for assigning email addresses for that domain. The prize winners will be notified at least once per business day for five (5) days beginning on the day the entry is drawn and will have seven (7) days to respond to the prize notice. If a prize winner does not respond within seven (7) days from the initial notification, then CUPAC will randomly draw a new prize winner from the remaining entries and the first prize winner shall be voided. The new prize winner shall be subject to the same rules. The prize winners who notify CUPAC within the required time period and accept the prize will be sent a W-9 form as applicable for the grand prize value.

Prize Restrictions: All taxes in connection with the prize, and the reporting consequence thereof, are the sole responsibility of the prize winner. Delivery of prize(s) will be made in the year 2022. You are only eligible to receive one prize from Sponsor per sweepstakes.
